The petitioner is the owner owner in possession of a property having an extend of 2.43 Ares in Re-Sy.No.854/2, 1.81 Areas in Re-Survey NO.845/2 and 1.63 Areas in Re-Sy No.845/1 of Pariyaram Village, Mukundapuram Taluk, Thrissur district.
