## **JUDGMENT**

This writ petition is filed by the petitioner seeking the following reliefs:

- i) issue a writ of mandamus or other appropriate writ, order or direction commanding the 1<sup>st</sup> respondent to complete the demarcation/re-fixing of boundary proceedings as per Ext.P3 forthwith.
- ii) To direct the 1<sup>st</sup> respondent to consider and pass appropriate orders on Ext.P4 and pass appropriate orders on Ext.P4 representation expeditiously.
- iii) Grant such other reliefs as may be prayed for in the circumstances of the case.

2. Subject issue relates to the application submitted by the petitioner for fixation of boundary and other consequential reliefs before the 1<sup>st</sup> respondent. The sole relief sought for by the petitioner is, early finalisation of Ext.P3 proceedings by the 1<sup>st</sup> respondent.

Having heard learned counsel for petitioner and learned Government Pleader, the writ petition is disposed of directing the Taluk Surveyor, Adoor, Pathanamthitta, to finalise the proceedings pertaining to Ext.P3, at the earliest and at any rate, within one month from the date of receipt of a copy of this judgment, after providing a notice of participation to all concerned.
