No. 1328 of 2020 and Manikandan, male, aged about 25 Years, S/o. Palani (Late) in H.C.P. No. 861 of 2020, now confined in Central Prison, Vellore for a period of 15 days without police escort.

**COMMON ORDER**

[Order of the Court was made by *M.M.SUNDRESH, J.*]

The detenu in H.C.P.No.856 of 2020 was the father of the detenus in H.C.P. Nos.1328 and 861 of 2020. It appears that, as confirmed by the learned Additional Public Prosecutor, that the father, who was the detenu in H.C.P.No.856 of 2020 and the father of the detenus in H.C.P.Nos.1328 and 861 of 2020 expired yesterday –

30.10.2020. Seeking a direction to the respondents to grant parole to detenus Sasi Kumar @ Thangam, male, aged about 33 Years, S/o. Palani (Late) (TPDA No. 8085) in H.C.P. No. 1328 of 2020 and Manikandan, male, aged about 25 Years, S/o. Palani (Late) in H.C.P. No. 861 of 2020, now confined in Central Prison, Vellore for a period of 15 days without police escort, the present miscellaneous petitions have been filed.

2. The aforesaid factum is not in dispute. In fact the deceased was also a detenu. The detenus in H.C.P.Nos.1328 and 861 of 2020 are admittedly the sons of the detenu in H.C.P.No.856 of 2020 (since deceased).

3. Under those circumstances, we are inclined to direct the respondents to grant parole to the detenus in H.C.P.Nos.1328 and 861 of 2020 for a period of one week starting from today (31.10.2020) without escort. Accordingly, the detenus shall be released at 5.00 p.m. on 31.10.2020 and they shall return back to prison at 05.00 p.m. on 07.11.2020 subject to the usual conditions that can be imposed. During the leave period, the detenus shall report before the Inspector

of Police, Walajapet Police Station, Ranipet District daily at 5.00 a.m.,

4. We make it clear that the detenus, on return, will have to be tested as per the Jail procedure for COVID 19. Similarly, before releasing them also, the aforesaid test will have to be conducted.

5. In view of the above, the miscellaneous petitions stand disposed of.

Post the matter on 09.11.2020 'for reporting compliance'.


