Heard learned counsel for the petitioner as well as Sri Sampath Prabhakar Reddy, learned Standing Counsel for the Corporation and with their consent, at the admission stage, the Writ Petition is disposed of.

When it is confronted that under the provisions of the Greater Hyderabad Municipal Corporation Act, 1955, it is only the Commissioner / authorised delegate of the Commissioner who is entitled to issue the notice and take action, since the present proceedings dated 06.02.2020 was issued by the 2nd respondent - Deputy Superintendent of Police, EV & DM (Vigilance Wing), Greater Hyderabad Municipal Corporation, the learned Standing Counsel graciously agrees that the impugned proceedings itself is defective.

In that view of the matter, the proceedings dated 06.02.2020 is quashed, leaving it open to the respondent – Corporation to take action in accordance with law, as it is the specific assertion of the learned Standing Counsel that the action in this matter was taken, in terms of the order in Writ Petition No. 2395 of 2020. No costs.
