ORDER:

Heard learned counsel for the petitioner, and Sri N. Ashok Kumar, learned

Standing Counsel.

It is a case where the closure orders passed under Section 622 of the GHMC

Act are challenged with the allegation that as per the impugned order, the

petitioner was found to be running the tile manufacturing unit without necessary

permissions and also further causing pollution apart from nuisance by storing the

clay and other products.

Though the learned counsel for the petitioner, by relying on some

photographs in support of his case, submits that there is no nuisance being caused

as alleged, as it is not possible for this court to physically examine and come to a

conclusion on the aspect of whether the petitioner is causing nuisance and also

pollution endangering the neighbouring residents, that too in a residential area,

liberty is given to the petitioner to approach the competent authority/authorised

officer of the respondent Corporation and seek necessary permission by placing

relevant material, which he seeks to rely on, before the authorities for reopening

his manufacturing unit. Upon the petitioner approaching the competent authority

by placing relevant material in support of his case, the competent

authority/authorised officer of the respondent Corporation shall, within a period of

two weeks from the date of placing relevant material by the petitioner, consider the

same and pass necessary orders, in accordance with law.

Subject to the above, the writ petition is disposed of. No costs.

Miscellaneous petitions, if any pending, shall stand closed.
