ORDER:

This Writ Petition is filed for the following relief:

- "...to issue an appropriate writ, order direction more particularly one in the nature of Writ of Mandamus declaring the action of the respondents in not releasing the power supply to the petitioner building at premises bearing open place admeasuring 174 square yards in Survey Nos.357, 66 square yards in Sy.No.366 total admeasuring to 240 square yards open place admeasuring 335 square yards in survey No.362, open place admeasuring 282 square yards in Sy.No.368 situated at Nizampet Village and Gram Panchayat, Bachupally Mandal, Medchal-Malkajgiri District, as illegal, null, void, arbitrary and consequently direct the respondents to release the power supply without insisting for occupancy certificate..."
- When the matter is taken up, it is submitted by the learned counsel for the petitioner that the issue raised in the present Writ Petition is squarely covered by the order dated 26.07.2018 passed by this Court in W.P.No.26085 of 2018.
- 3. Sri R.Vinod Reddy, learned Standing Counsel for Telangana State Southern Power Distribution Company Limited, appearing for respondent Nos.1 to 3 and Sri Chatla Madhu, learned Standing Counsel for Grater Hyderabad Municipal Corporation, appearing for respondent No.4, do not dispute the aforesaid submission.
- 4. In view of the above, for the reasons alike in the said order, this Writ Petition is disposed of directing the respondents to release power supply to the premises of the petitioner subject to the compliance of the terms and conditions and on furnishing an undertaking to produce the occupancy certificate fro the concerned Municipal Corporation within a prescribed period, and if no such occupancy certificate is produced.

within such period, it is open to the respondents to take appropriate action in accordance with law.

Miscellaneous applications, if any, pending shall stand closed of. There shall be no order as to costs.
