Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ or Order one in particularly a WRIT OF MANDAMUS declaring the action of respondents in not releasing the Auto Rickshaw Vehicle bearing No AP24-W-4541, in favour of petitioner being illegal, irregular, arbitrary and in violation of principles of natural justice and consequently direct the respondents to release the Auto Rickshaw Vehicle bearing No AP24-W-4541, in favour of petitioner on him furnishing the personal bond or solvent sureties.

# THE HON' BLE SRI JUSTICE CHALLA KODANDA RAM WRIT PETITION No.9378 of 2020

## ORDER:

The petitioner's Auto Rickshaw bearing Registration No.AP-24-W-4541 was intercepted and selzed by the 4th respondent - SHO, Dindi P.S., on 06.11.2019 on the ground that the vehicle was used for illegal transportation of 5 quintals of PDS Rice. A case in FIR No.107 of 2019 for the offences under Section 420 of IPC, and Section 7 of Essential Commodities Act has been registered. It is the case of the petitioner that the vehicle was on hire for transportation purpose, and the petitioner has nothing to do with the alleged offence.

Heard Sri Viplav Simha Reddy, learned counsel for the petitioner, and learned Government Pleader for Civil Supplies.

Having considered the respective submissions, as enquiry is required to be conducted, the writ petition is disposed of with a direction to respondent No.4-SHO, Dindi P.S., to release the vehicle No.AP-24-W-4541 on the petitioner furnishing immovable property security for a sum of Rs.25,000/- (Rupees Twenty five thousand only) with the 3<sup>rd</sup> respondent; and also furnishing an undertaking that he shall not alienate or change the physical features of the vehicle. The 3<sup>rd</sup> respondent shall also write to the RTA authority to not transfer the vehicle on any third parties name without clearance from the Civil Supplies Department. The release of vehicle is in view of the situation on account of COVID-19, and the release shall be subject to the orders to be passed by the respondent authorities in the enquiry under the provisions of Essential Commodities Act. No costs. Miscellaneous petitions, if any pending, shall stand closed.
