WRIT PETITION No.9460 OF 2020

ORDER:

This Writ Petition is filed for the following relief:

"...to issue a writ, order direction more particularly one in the nature of Writ of Mandamus declaring the action of the respondents in not releasing the electricity connections pertaining to the plot No.22P in Sy. Nos.313, 314 & 315 at 364, bearing SC.No.00415-29589 at Nizampet Section of Miyapur Sub-Division in Kukatpally Division of Medchal Circle is being illegal, arbitrary and unconstitutional and in violation of principles of natural justice and Article 21 and consequently direct the official respondent to release power supply to the same without insisting for occupancy certificate..."

2. When the matter is taken up, it is submitted by the learned counsel for the petitioner that the issue raised in the present Writ Petition is squarely covered by the order dated 26.07.2018 passed by this Court in W.P.No.26085 of 2018.

3. Learned Government Pleader for Energy, appearing for respondent No.1 and Sri R.Vinod Reddy, learned Standing Counsel for Telangana State Southern Power Distribution Company Limited, appearing for respondent Nos.2 to 4, do not dispute the aforesaid submission.

4. In view of the above, for the reasons alike in the said order, this Writ Petition is disposed of directing the respondents to release power supply to the premises of the petitioner subject to the compliance of the terms and conditions and on furnishing an undertaking to produce the occupancy certificate fro the concerned Municipal Corporation within a prescribed period, and if no such occupancy certificate is produced within such period, it is open to

the respondents to take appropriate action in accordance with law.

Miscellaneous petitions pending, if any, shall stand disposed of.

There shall be no order as to costs.
