# CRIMINAL PETITION No. 3073 of 2020

## ORDER:

The Criminal Petition, under Section 438 of the Code of Criminal Procedure, 1973, is filed by the petitioner/A-1 seeking to grant anticipatory bail in the event of his arrest in connection with Crime No.213 of 2019 of Nacharam Police Station, Rachakonda, which was registered for the offences punishable under Sections 420, 406, 419, 468 and 471 read with Section 34 of I.P.C.

Heard the learned counsel appearing for the petitioner, learned Assistant Public Prosecutor appearing for the respondent-State and perused the record.

Learned counsel for the petitioner would submit that the petitioner is innocent and he is nothing to do with the alleged offence and he has been falsely implicated in this case. He further submits that O.S.No.718 of 2019 is pending between the parties before the Principal Junior Civil Judge, Ranga Reddy District at L.B.Nagar and the present complaint is lodged only to convert the civil litigation into criminal nature. He also submits that the petitioner is ready to abide by any conditions that may be imposed in the event of his enlargement on anticipatory bail.

Learned Assistant Public Prosecutor opposed to grant anticipatory bail to the petitioner.

As seen from the contents of the First Information Report, the present petitioner/A-1 in this case had received the amount from the *de facto* complainant in the year 2018 itself and got the land registered in favour of the *de facto* complainant on 26.11.2008. Further, as per the material available on record a civil suit is pending between the parties. Thus, looking into the nature of allegations levelled against the petitioner/A-1 and having regard to the other facts and circumstances of the case, without delving into the merits of the case, I am inclined to grant anticipatory bail to the petitioner/A-1.

Accordingly, the Criminal Petition is allowed and the petitioner/A-1 is granted anticipatory bail subject to the following terms and conditions:

- (1) The petitioner/A-1 is directed to surrender before the Station House Officer, Nacharam Police Station, Rachakonda, within a period of four (04) weeks from the date of this order and on such surrender, the said Station House Officer shall release him on bail on his executing a personal bond to the tune of Rs.15,000/- (Rupees fifteen thousand only) with two sureties to the like amount each to his satisfaction.
- (2) The petitioner/A-1 shall abide by the other conditions stipulated in Section 438(2) Cr.P.C and co-operate with the Investigating Officer in investigating the case.
