Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ of Mandamus or any other appropriate Writ or Writs, Order or Orders questioning the action of Respondent No.4 in not issuing the patta Passbooks and title Deeds in respect of Petitioner land admeasuring Ac.5.00 Gts in Sy.No.19/174/AA Situated at Nellipaka Village, Aswapuram Mandal, Khammam District, Telangana is illegal, contrary to the AP ROR Act, law and against to the principal of natural justice and consequently to Direct the Respondent No.4 to consider the representation Dated 29.06.2020 of petitioner for issuance of Patta Pass Books and title Deeds in respect of schedule property and pass orders as per law.

THE HON'BLE SRI JUSTICE A.ABHISHEK REDDY WRIT PETITION No.11569 of 2020 ORDER:

Heard the learned counsel for the petitioner and the learned Government Pleader for Revenue for respondents. With their consent, the Writ Petition is disposed of at the stage of admission.

This writ petition is filed questioning the inaction of respondent No.4-Tahsildar in disposing of the representation, dated 29.06.2020; submitted by the petitioner seeking mutation of her name in the revenue records in respect of the land admeasuring Acs.5-00 guntas in Survey Nos.19/174/AA situated at Nellipaka Village, Aswapuram Mandal, Khammam District, Telangana.

The learned counsel for the petitioner states that the petitioner has made the aforesaid representation to the respondent No.4-Tahsildar seeking mutation of her name in the revenue records in respect of the subject land. However, no orders are passed thereon till date. Hence, he seeks a direction to respondent No.4 to dispose of the representation of the petitioner, at the earliest.

The learned Government Pleader, on instructions, states that due to the present pandemic situation, the representation, dated 29.06.2020, submitted by the petitioner could not be disposed of and seeks some time for passing necessary orders on the said representation.

In view of the above submission, the Writ Petition is disposed of directing respondent No.4-Tahsildar, Aswapuram Mandal, Aswapuram, Kothagudem, Bhadradri Kothagudem District, to dispose of the representation submitted by the petitioner on 29.06.2020 and pass necessary orders thereon, strictly in accordance with law, as expeditiously as possible, preferably within a period of three months from the date of receipt of a copy of this order. It is needless to mention that the respondent No.4 before passing any orders shall put the petitioner as well as any other interested persons on notice and give them an opportunity of hearing. A copy of the order passed by the respondent No.4 will be communicated to the parties.

The miscellaneous petitions pending, if any, shall stand closed. There shall be no order as to costs.
