**ORDER:**

This Criminal Petition, under Section 439 of the Code of Criminal Procedure, 1973, is filed by the petitioner/accused seeking to grant regular bail in Crime No.2 of 2020 of Boinpalli Police Station, Rajanna Sircilla District, registered for the offences punishable under Sections 448, 324 and 506 I.P.C. and Sections 3(1)(r)(s) and 3(2)(va) of the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Amendment Act, 2015.

2. Heard learned counsel for the petitioner/accused and the learned Additional Public Prosecutor appearing for the respondent/State and perused the record.
3. Learned counsel for the petitioner/accused submitted that the petitioner/accused was arrested on 21.08.2020.
4. Learned Additional Public Prosecutor submitted that entire investigation is completed, except filing of charge sheet.
5. In these circumstances, this Court is inclined to grant bail to the petitioner/accused.
6. Accordingly, the present Criminal Petition is allowed granting bail to the petitioner/accused with the following conditions:
  - i) The petitioner/accused shall furnish a personal bond for an amount of Rs.10,000/- (Rupees ten thousand only)

with two (02) sureties for like sum each to the satisfaction of Metropolitan Magistrate, Vemulawada;

- ii) The petitioner shall not cause inducement of any nature to the prosecution witnesses.
- iii) The petitioner/accused shall appear before the Station House Officer, Boinpalli Police Station, Rajanna Sircilla District, on every Sunday between 10:00 AM and 11:00 AM, till filing of charge sheet.

As a sequel, miscellaneous petitions, if any, pending in this Criminal Petition shall stand closed.
