# THE HON BLE SRI JUSTICE ABHINAND KUMAR SHAVILI WRIT PETITION No.17081 OF 2020

### ORDER:

This writ petition is being disposed of at the admission stage with the consent of both the parties.

Heard Sri V.Narsimha Goud, learned counsel for the petitioner and the learned Standing counsel for the respondents.

This writ petition is filed secking the following relief:-

It has been contended by the petitioner that he has been working as ADC/Controller with the respondents. While so, the petitioner was issued a show cause notice dt.25.06.2020 for recovery of amount basing on the audit report of the 3rd respondent. Pursuant to the said show cause notice, petitioner submitted explanation on 11.08.2020 stating that he was not served with the basic report of the 3rd respondent. The grievance of the petitioner is that the respondents without furnishing the document sought by him and without considering his explanation issued punishment proceedings 02/95(10)/2000-MDCL.

Therefore, learned counsel for the petitioner contends that since the respondents have passed impugned recovery order without furnishing the documents requested by the peritioner and

without considering the explanation submitted by the petitioner, the action of the respondents is arbitrary and the impugned order is liable to be set aside.

Learned Standing counsel appearing for the respondents contends that the respondents would furnish the documents requested by the petitioner and thereafter would re-consider the case of the petitioner by duly taking into account the explanation submitted by the petitioner and pass appropriate orders in accordance with law.

Plaving considered the rival submissions made by the parties, this writ petition is allowed and the impugned recovery order dated 15.09.2020 is set aside giving liberty to the respondents to pass afresh orders after furnishing the necessary documents requested by the petitioner and affording reasonable opportunity to the petitioner. No order as to costs.

As a sequel, miscellaneous petitions pending, if any, in this writ petition shall stand closed.
