Petition under Section 438 of Cr.P.C, praying that in the circumstances stated in the grounds filed in support of the Criminal Petition, the High Court may be pleased to enlarge the petitioner on bail in the event of his arrest in connection with Crime No. 701 of 2020 of P.S. Madhapur, Cyberabad, Ranga Reddy District.

The petition coming on for hearing, upon perusing the Petition and the grounds filed in support thereof and upon hearing the arguments of MR.D.BHASKAR REDDY Advocate for the Petitioner and PUBLIC PROSECUTOR (TG) for the Respondent, the Court made the following.

ORDER

CRIMINAL PETITION No.5369 OF 2020

ORDER:

This application, under Section 438 of Cr.P.C., is filed for grant of anticipatory bail. The petitioner is accused No.1 in Crime No.701 of 2020 pending on the file of Madhapur (Guttala) Police Station, Cyberabad. The offences alleged against the petitioner are under Sections 498-A IPC and 3 & 4 of the Dowry Prohibition Act.

2. Heard learned counsel for the petitioner and the learned Public Prosecutor for the respondent-State and perused the record.

3. Learned counsel for the petitioner-A1 submitted that the marriage between the petitioner-A1 and the *de facto* complainant was performed on 28.11.2019 and the *de facto* complainant has stayed with A1 for a few months and thereafter, she has filed the present complaint with all false and baseless allegations. Learned counsel further submitted that the Court below granted anticipatory bail to A2 to A4, who are father, mother and brother of A1 vide order dated 14.10.2020. However, the Court below dismissed the bail application in respect of the petitioner-A1.

4. From a reading of the complaint lodged by the *de facto* complainant it appears that from day one of the marriage between the petitioner and the *de facto* complainant there are serious marital disputes between them and that the marriage is irretrievably broken down. Though several allegations are made with regard to dowry harassment and

subjecting the *de facto* complainant to physical and mental cruelty, such allegations are vague. The *de facto* complainant is a doctor.

5. In the facts and circumstances of the case, this Court is inclined to grant anticipatory bail to the petitioner-A1.

6. Accordingly, the Criminal Petition is allowed and the petitioner-A1 is granted anticipatory bail on the following conditions:

- i) The petitioner-A1 is directed to surrender before the Station House Officer, Madhapur (Guttala) Police Station, Cyberabad, within a period of fifteen (15) days from today, and on such surrender, the said Station House Officer shall release the petitioner on bail on his executing a personal bond for a sum of Rs.10,000/- (Rupees ten thousand only) with two sureties for a like sum each to his satisfaction.
- ii) The petitioner-A1 shall abide by the conditions stipulated in Section 438 (2) of Cr.P.C and cooperate with the Investigating Officer in investigating the crime.
- iii) The petitioner-A1 shall personally appear before the concerned Investigating Officer on every Wednesday and Sunday between 10.00 AM and 5.00 PM, till completion of investigation and filing of charge sheet.

Miscellaneous petitions, if any pending, shall stand closed.
