Petition under Sections 437 & 439 of Cr.P.C. praying that in the circumstances stated in the grounds filed in support of the Criminal Petition, the High Court may be pleased to enlarge the petitioners/ accused No. 1 on Regular Bail in Crime No. 390 of 2020 on the file of SHO, Excise, Dhoolpet Police Station, Hyderabad, and release the petitioner/ accused no.1 on such terms and conditions.

The petition coming on for hearing, upon perusing the Petition and the grounds filed in support thereof and upon hearing the arguments of SRI G RAVI CHANDRA SEKHAR Advocate for the Petitioner and PUBLIC PROSECUTOR for the Respondent, the Court made the following.

ORDER:

THE HONOURABLE SRI JUSTICE K, LAKSHMAN CRIMINAL PETITION No.6206 OF 2020

ORDER:

This is an application for regular bail. The petitioner herein is accused No.1 in Crime No.390 of 2020 of Excise Police Station, Dhoolpet, Hyderabad. The offence alleged against the petitioner is under Section 8(c) read with Section 20(b) (ii) (c) of the N.D.P.S. Act, 1985.

- Heard learned counsel for the petitioner and learned
 Public Prosecutor. Perused the record.
- 3. On perusal of the remand report would reveal that 20.70 kgs., of dry ganza was seized from the accused. The said quantity is 0.7 kgs., more than the commercial quantity. The petitioner is in jail from 24.09.2020. The petitioner is a driver.
- 4. On instructions, learned Public Prosecutor would submit that the petitioner is not involved in any case for the offence under the provisions of the NDPS Act. The Police have almost completed the investigation by recording the statements of material witnesses.
- Considering the said aspects, this Court is inclined to grant bail to the petitioner.

Accordingly, the Criminal Petition is allowed and the 6. petitioner is granted regular bail subject to the following conditions:

i. The petitioner shall execute a personal bond for a sum of Rs.10,000/- (Rupees ten thousand only) with two sureties for the like sum each to the satisfaction of the Judicial First Class Magistrate at Yellandu.

ii. The petitioner shall appear before the Station House Officer, Excise Police Station, Dhoolpet, Hyderabad, on every Sunday between 10.00 AM and 5.00 PM, till completion of investigation and filing of final report.

iii. The petitioner shall cooperate with the Investigating Officer.

Miscellaneous petitions pending, if any, shall stand disposed of.
