Petition under Section 438 of Cr.P.C, praying that in the circumstances stated in the grounds filed in support of the Criminal Petition, the High Court may be pleased to grant Anticipatory Bail to the Petitioner/A7 in the event of arrest in Cr, No. 138 of 2019 of P.S. LMD colony, Karimnagar in the interest of Justice.;

The petition coming on for hearing, upon perusing the Petition and the grounds filed in support thereof and upon hearing the arguments of SRI P RANA KAMALASAN Advocate for the Petitioner and PUBLIC PROSECUTOR for the Respondent, the Court made the following

ORDER:

ORDER:

This application is filed seeking anticipatory bail. The petitioner is A7 in Crime No.138 of 2019 of LMD Colony, Karimnagar District. The offences alleged against the petitioner are under Sections 341, 324, 506 read with 34 IPC.

Heard learned counsel for the petitioner and learned Public Prosecutor. Perused the record.

The only allegation against the petitioner herein is that he has also participated in the alleged incident mentioned in the complaint. Except that one sentence there was no other allegation. A3 and A4 were enlarged on regular bail.

On instructions, learned Public Prosecutor would submit that the police have invoked the procedure laid down under Section 41-A Cr.P.C. on the petitioner.

Considering the said aspects, this Court is inclined to grant anticipatory bail to the petitioner/A7.

Accordingly, this Criminal Petition is allowed. The petitioner/A7 is directed to surrender before the Station House Officer, LMD Colony Police Station, Karimnagar District, within a period of 15 days from the date of this order. On such surrender, the said Station House Officer shall release the petitioner/A7 on bail on his executing personal bond for a sum of Rs.10,000/- (Rupees ten thousand only) with two sureties for the like sum each to his satisfaction. Further, the petitioner/A7 shall abide by the

conditions stipulated in Section 438 (2) Cr.P.C and shall co-operate with the Investigating Officer in investigating the case.

Miscellaneous petitions, if any, pending in this criminal petition, shall stand closed.
