The Court made the following: ORDER

In the instant case, the writ petition was disposed of by Hon'ble Sri Justice M.S. Ramachandra Rao. However, in the first page of the order of writ petition dt 6.2.2019 enclosed to the Contempt Case paper book, my name was shown and in the second page, the name of Hon'ble Sri Justice M.S.Ramachandra Rao was shown. In the prayer portion of the contempt case also, petitioner has typed my name. During the course of hearing also, the Court was not informed that the actual order was passed by the Hon'ble Sri Justice M.S.Ramachandra Rao.

Having regard to the submission of learned counsel on both sides that orders passed in W.P. No. 964 of 2019 dt 6.2.2019 were complied with, this Court by order dated 24.9.2020 closed the contempt case.

Later on noticing that the contempt case was wrongly listed before me, the matter is listed today under the caption 'for being mentioned'.


As per the procedure evolved in this Court and assignment of work by the Hon'ble Chief Justice, Contempts are listed before the judge who passes the order in the writ petition. The said contempt cases come before the judge dealing with the concerned Department as per the roster determined by the Hon'ble Chief Justice, only if the judge who has passed the order is not serving in the High Court.

As the case was wrongly listed before me, the order dated 24.9.2020 in C.C. No. 1178 of 2019 is recalled and office is directed to

place the contempt case before the Hon'ble Sri Justice M.S.Ramachandra Rao, for appropriate orders.
