Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ order or direction more particularly one in the nature of Writ of Mandamus, declaring the action of the Respondent Nos.2 and 3 in Interfering with the petitioner's business running in the premises of Hazrath Abdul Nabi Shah Saheb Complex, Hanamkonda, Warangal basing on the frivolous complaints and tweets made by the 4<sup>th</sup> respondent without following due procedure of law as illegal, arbitrary, contrary to the Municipalities Act and violation of Article 21 of Indian Constitution and consequently direct the 2<sup>nd</sup> and 3<sup>rd</sup> respondents not to interfere with the business of the petitioner.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the 2<sup>nd</sup> and 3<sup>rd</sup> respondents not to interfere with the business of the petitioner running in the premises of Hazrath Abdul Nabi Shah Saheb Complex, Hanamkonda, Warangal, pending disposal of the Writ Petition.

**ORDER:**

Heard learned counsel for the petitioner, learned Government Pleader for Municipal Administration and Urban Development for respondent No.1, and Ms.Pingali Lakshmi, learned Standing Counsel for Warangal Municipality appearing for respondent Nos.2 and 3. With their consent, the Writ Petition is disposed of at the stage of admission itself.

The present writ petition is filed by the petitioner aggrieved by the action of the respondent Nos.2 and 3 in interfering with the scrap business of the petitioner located in the premises of Hazrat Abdul Nabi Shah Sahab Complex, Hanamkonda, based on the frivolous complaints made by respondent No.4.

Learned Standing Counsel, on instructions, has stated that the official respondents are not interfering with the business of the petitioner, and in case, if they need to do so, they will do it in accordance with law.

In view of the above made submissions, the grievance of the petitioner stands redressed and the Writ Petition is disposed of directing the official respondents not to interfere with the business activity of the petitioner, except in accordance with the procedure established by law.

The miscellaneous petitions pending, if any, shall stand closed. There shall be no order as to costs.


