This writ petition is filed seeking writ of mandamus declaring the inaction of the 3rd respondent in considering the application of the petitioner dated 06.10.2020 for his appointment as Fair Price Shop dealer on compassionate appointment for shop No.2244002 of Peddabeeravalli village being legal heir of the deceased FPS dealer Basavaiah (FPS No.2244002) of Peddabeeravalli village as illegal and arbitrary and in violation of G.O.Ms.No.4, dated 28.02.2014 and also in violation of Telangana State Public Distribution System (Control) Order, 2016 and for consequential directions.

Heard Sri S.Viplav Simha Reddy, learned counsel for the petitioner and learned Assistant Government Pleader for Civil Supplies appearing for respondent No.1.

Since it is stated that the grievance of the petitioner is already pending before the competent authority by way of representation dated 06.10.2020, it is for the competent authority to consider and dispose of the same.

With the above direction, this Writ Petition is disposed of, As a sequel thereto, miscellaneous applications, if any, pending shall stand closed.
