Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a Writ, order or direction, more particularly one in the nature of a Writ of Mandamus, declaring the action of the respondents in not providing an electrical service connection (Power connection)/meter in respect of the property owned by the petitioner bearing Plot No.08 admeasuring 484 square yards in Sy No. 1007 situated at Century Hills Kukatpally Revenue Village, Balanagar Mandal, Rangareddy District, within the limits of Kukatpally Circle and violative of Article 14, 21 and 300 A of the Constitution of India and consequently direct the respondents to provide an electricity connection (Power connection)/meter to the petitioner's house plot bearing Plot No.08 admeasuring 484 square yards in Sy No. 1007 situated at Century Hills Kukatpally Revenue Village, Balanagar Mandal, Rangareddy District, within the limits of Kukatpally Circle.

IA NO: 1 OF 2020

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents to provide an electrical service connection (Power connection)/meter in respect of the property owned by the petitioner bearing Plot No.08 admeasuring 484 square yards in Sy No. 1007 situated at Century Hills Kukatpally Revenue Village, Balanagar Mandal, Rangareddy District, within the limits of Kukatpally Circle pending disposal of the Writ Petition.

The Court made the following: ORDER

WRIT PETITION No.24480 of 2020

ORDER:

Heard learned counsel for the petitioner and Sri R.Vinod Reddy, learned Standing Counsel appearing for respondent Nos.1 to 4. With their consent, the Writ Petition is disposed of at the stage of admission itself.

The main grievance of the petitioner is that the respondents are not providing electrical service connection/meter in respect of Plot No.08, admeasuring 484 square yards, in Survey No.1007 situated at Century Hills, Kukatpally Revenue Village, Balanagar Mandal, Ranga Reddy District, within the limits of Kukatpally Circle.

The learned counsel for the petitioner has stated that though the petitioner has submitted an application to the respondents along with necessary documents for providing electricity service connection to the subject plot, the respondents are refusing to receive the same. The learned counsel has also stated that in similar circumstances, this Court has passed orders in W.P.No.10869 of 2020, dated 21.07.2020.

Sri R. Vinod Reddy, the learned Standing Counsel, on instructions, submits that if the petitioner files an application afresh, the same would be processed and necessary orders would be passed and the same would be intimated to the petitioner.

Recording the aforesaid submission, this Writ Petition is disposed of with a direction to the petitioner to file an application afresh for providing electricity service connection to the subject plot within a period of one week from the date of receipt of a copy of this order. On such application being filed, the respondents

shall receive and process the same and pass necessary orders thereon in accordance with the prescribed procedure and communicate the same to the petitioner, within a period of four weeks thereafter.

The miscellaneous petitions pending, if any, shall stand closed. There shall be no order as to costs.


