Heard learned counsel for the petitioners and learned Public
Prosecutor through video conferencing.

These bail applications have been filed under Section 439
Cr.P.C in connection with FIR No.347/2019 registered at Police
Station Ranoli, Sikar for the offences under sections 143,323,341,
395 and 382 IPC and section 3/25 of Arms Act.

Learned counsel for the petitioners submits that co-accused Ashish Sharma @ Ashu, Vidhadhar and Mahipal Kedia have been enlarged on bail by the co-ordinate bench of this court and the case of the petitioners is not distinguishable to that of co-accused. Petitioners are behind the bars since long and the conclusion of the trial will take a long, hence they may be released on bail.

Learned Public Prosecutor opposed the bail application.

Considering the submissions made by learned counsel for the petitioners and the fact that co-accused have been enlarged on bail by the coordinate bench of this court but without expressing any opinion on the merits/demerits of the case, this court deems it just and proper to enlarge the petitioners on bail.

Accordingly, the bail applications under Section 439 Cr.P.C. are allowed and it is ordered that the accused-petitioners Kamlesh Kumar @ Kamal son of Chetram and Tejpal son of Shri Jagdish Prasad shall be enlarged on bail in the aforesaid FIR provided each of them furnishes a personal bond in the sum of Rs.50,000/- with two sureties of Rs.25,000/- each to the satisfaction of the learned trial Judge for their appearance before the court concerned on all the dates of hearing and as and when called upon to do so.
