**Order**

The present bail application has been filed under Section 439 Cr.P.C. The petitioners have been arrested in connection with FIR No. 141/2019 registered at Police Station Gopalgarh, District Bharatpur for the offence(s) under Section(s) 143, 323, 341 and 354 of I.P.C.

Heard learned counsel for the parties through Jitsi Meet.

It is contended by learned counsel for the petitioners that there are omnibus allegations against as many as 16 accused persons with no specific allegation against the present petitioners

of inflicting blow on the person of injured Akhvari. He submits that there are cross cases, petitioners are in custody since 23.02.2020, investigation as against them is complete, trial of the case is likely to take time and therefore, prays for release of the petitioners on bail.

Learned Public Prosecutor assisted by learned counsel for the complainant opposed the bail application.

Taking into consideration the submissions advanced by learned counsel for the petitioners, nature of accusation and their length of the custody; but, without expressing any opinion on the merits of the case, this court deems it just and proper to enlarge the petitioners on bail.

Accordingly, the bail application is allowed and it is directed that accused-petitioners **1. Farooq S/o Suban Khan, 2. Fazru S/o Suban Khan and 3. Maksood S/o Suban Khan** shall be released on bail under Section 439 Cr.P.C. in connection with afore-mentioned FIR registered at concerned Police Station, provided each of them shall furnish a personal bond in the sum of Rs.1,00,000/- (Rupees One Lac only) together with one surety in the sum of Rs.50,000/- (Rupees Fifty Thousand only) to the satisfaction of the trial court with the stipulation that they shall comply with all the conditions laid down under Section 437(3) Cr.P.C.
