This bail application has been filed under Section 439 Cr.P.C.

Brief facts of the case are that an FIR No. 703/2019 was registered at P.S. Mathura Gate, Bharatpur Distt. Bharatpur for the offences mentioned therein against the accused petitioner.

During the course of investigation, the accused petitioner was arrested. Thereafter petitioner moved the bail application before the trial court, which vide impugned order dismissed the same. Hence this bail application has been filed on behalf of the petitioner.

Learned counsel for the petitioner has submitted that the petitioner is behind the bar for the last approx. nine months. The petitioner has falsely been implicated in the present case as he has no criminal antecedents. The petitioner has remained in

judicial custody for sufficient period, no recovery has to be made from the possession of the petitioner, unnecessary detention of the petitioner is not warranted and the trial of the case is likely to take considerable time, hence the accused petitioner be released on bail.

On the other hand, learned Public Prosecutor has opposed the bail application.

Taking into consideration the submissions advanced by the learned counsel for accused petitioner and considering the contentions to put forth, note of the allegations levelled against the petitioner as also looking to the facts and circumstances of the case, but without expressing any opinion on the merits and demerits of the case, I deem it just and proper to release the petitioner on bail.

Therefore, this bail application is allowed and it is directed that accused petitioner **Ajay Singh S/o Shivram** shall be released on bail under Section 439 Cr.P.C. in connection with aforementioned FIR registered at concerned Police Station, provided he/she/they furnish/es a personal bond in the sum of Rs.50,000/- (Rupees fifty thousand) together with two sureties in the sum of Rs.25,000/- (Rupees twenty five thousand only) each to the satisfaction of the trial court with the stipulation that he/she/they shall appear before that court on all subsequent dates of hearing and as and when called upon to do so.
