Heard the learned counsel for the petitioners through Video Conferencing as well as learned Public Prosecutor, present in the Court.

Learned counsel for the petitioners submitted that allegations against the petitioners are punishable under Sections 419, 420, 406 and 120-B IPC and these offences are triable by the Magistrate. Learned counsel further submitted that the petitioner No.1 was implicated in another case and Principal Seat at Jodhpur has granted bail to the petitioner No.1 while allowing **S.B.**

**Criminal Misc. Bail Application No.4124/2020 (Abhishek Ranjan Versus State of Rajasthan)** dated 05.05.2020.

Learned counsel further submitted that the recovery of Rs.12 lakhs have also been made from the petitioner/s during investigation.

Learned Public Prosecutor has opposed the bail application.

This Court, considering the nature of offences alleged against the petitioners and grant of bail to the petitioner No.1 by Coordinate Bench of Principal Seat at Jodhpur, without expressing any opinion on the merits of the case, this Court deems it just and proper to release the petitioners on bail.

Accordingly, the present bail application under Section 439 Cr.P.C. is allowed and it is ordered that the accused-petitioners Abhishek Ranjan S/o Ramesh Chand Pandey and Ajay Vishwakarma S/o Rameshwar Vishwakarma, shall be released on bail in connection with FIR No.115/2019, registered at Police Station Reservation Centre Kotwali, Bundi, provided each of them furnishes a personal bond in the sum of Rs.50,000/- with one surety of alike amount to the satisfaction of the learned trial Judge for their appearance before the Court concerned on all the dates of hearing and as and when called upon to do so.
