**HON'BLE MR. JUSTICE PANKAJ BHANDARI**

**Order**

1. Petitioners have filed these bail applications under Section 439 of Cr.P.C.
2. F.I.R. No. 182/2020 was registered at Police Station

Surajgarh, Jhunjhunu for offence under Section 395 of I.P.C.

3. It is contended by counsel for the petitioners that police after investigation has found the case to fall under Sections 380 and 408 IPC.

4. Learned Public Prosecutor and counsel for the complainant have opposed these bail applications.

5. I have considered the contentions.

6. Considering the contentions put forth by counsel for the petitioners, I deem it proper to allow these bail applications.

7. These bail applications are accordingly allowed and it is directed that accused petitioners shall be released on bail provided each of them furnishes a personal bond in the sum of Rs.1,00,000/- (Rupees One Lac only) together with two sureties in the sum of Rs.50,000/- (Rupees Fifty Thousand only) each to the satisfaction of the learned trial court with the stipulation that they shall appear before that Court and any court to which the matter is transferred, on all subsequent dates of hearing and as and when called upon to do so.

8. A copy of this order be sent to concerned S.H.O. for recording this condition in the Village Crime Record Book so that in the event of petitioner's repeating offence, S.H.O. can move the Court for cancellation of bail.
