Order

Lawyers are abstaining from work in view of the unprecedented situation being faced by the country due to pandemic of novel corona virus (COVID-19).

Both the aforesaid bail applications shall stand decided by this common order as they arise out of the same F.I.R.

The present bail applications have been filed under Section 439 of Cr.P.C. on behalf of the petitioners who are in custody in connection with F.I.R. No. 92/2020, Police Station Kotwali, District Nagaur for the offences under Sections 143, 323, 341, 427, 365 & 308 of I.P.C.

I have gone through the orders impugned as well as pleadings in the bail applications.

Mr. Farzand Ali, learned Additional Advocate General – cum – Government Advocate opposes the bail applications.

On 23.03.2020, the matter was directed to be listed on 30.03.2020. Since the Bench was not available on 30.03.2020 and therefore, the matter is listed today on the permission sought by the learned counsel for the petitioners, which is not opposed by the learned Additional Advocate General – cum – Government Advocate.

Having regard to the peculiar facts and circumstances of the case as also the present situation of the country due to pandemic of corona virus (COVID-19), in particular the jails, this Court deems it just and proper to release the petitioners on bail.

Consequently, both the bail applications filed under Section 439 of Cr.P.C. are allowed. It is ordered that the accused-petitioners **(1) Dinesh s/o Pusaram and (2) Shrawanram s/o Dhudaram** arrested in connection with F.I.R. No. 92/2020, Police Station Kotwali, District Nagaur shall be released on bail provided each of them furnishes a personal bond of Rs.50,000/- (Rupees: Fifty Thousand Only) with two sureties of Rs.25,000/- (Rupees : Twenty Five Thousand Only) each to the satisfaction of the learned
