Petitioner has prayed for the following relief(s):

- (i) For issuance of an order (s) / direction (s) or appropriate writ(s) for setting aside Para 5.4 of Statutes for appointment of Assistant Professor for the Universities of Bthar 2020 as well as the identical provision contained in Para 7.1 of the Advertisement dated 21.09.2020 issued by Bihar State University Service Commission inasmuch as the same is in clear violation of the UGC Regulations, 2018 and further direct the Bihar State Public Service Commission to prepare the final merit list for filling up the advertised posts of Assistant Professors only on the basis of the performance of the short-listed candidates in the Interview And/or
- (ii) For issuance of further order (s) / direction (s) or appropriate writ(s) for setting aside Para 3.7 read



with Table: 1 of Statutes for appointment of Assistant Professor for the Universities of Bihar -2020 as well as the identical provision contained in Para 7.2 of the Advertisement dated 21.09.2020 issued by Bihar State University Service Commission which prescribes distribution of points for short - listing of candidates for the post of Assistant Professors and further direct the Bihar State University Service Commission to short-list the candidates for appointment on the post of Assistant Professors in Colleges as per Table:3B of UGC Regulations, 2018. It is respectfully submitted that for short-listing of candidates for interview for the post of Assistant Professors in Colleges different criteria has been provided in **Table:3B** of UGC Regulations, 2018 but the same has not been incorporated in the Statutes for appointment of Assistant Professor for the Universities of Bihar - 2020. In other words, no Statute has been framed by the Respondents for appointment of Assistant Professors in Constituent Colleges in Bihar and thus no appointment can be made on the post of Assistant Professors in Constituent Colleges in Bihar on the basis of criteria laid down in Table: 1 of Statutes for appointment of Assistant



Professor for the Universities of Biker - 2020 which is almost identical to Table 3A of TIGC. Regulations, 2018 with the only major difference being that M.Phil stands deleted in Table. I. It is worth noting that more than 90% of the advertised vacancies of the Assistant Professor are for the purpose of filling up the vacant post of Assistant Professors in vacious Constituen. Colleges in Bihar and the rest 10% of the advertised vacancies are for the purpose of filling up the post of Assistant Professors in Limiteration. And in

(iii) For issuance of further order (s) / direction (s) or appropriate writ(s) for directing the Bihar State University Service Commission not to continue with the process of appointment on the post of Assistant Professor commenced vide advertisement dated 21.09.2020 without first Incorporating necessary provisions in Statutes for appointment of Assistant Professor for the Universities of Bihar 2026 so as to minimize any suspicion of favoritism, discrimination or arbitrary award of marks thus ensuring the fairness and transparency of the process of Interview.

And/or

(iv) Pass such other order/orders which may appear fit and proper in the facts and circumstances of the instant case."

It is not in dispute that the petitioner is otherwise eligible and can participate in the selection process in terms of advertisement dated 21.09.2020 [Annexure-3].

Petitioner lays challenge to the amendment dated



29th of August, 2020 brought in by the Secretary, Bihar State Universities Service Commission, vide Annexure-2 series whereby the provisions for award of certain marks for candidates possessing M.Phil. Degree stand deleted.

After the matter was heard for some time, learned counsel appearing for the petitioner, under instructions, states that petitioner be granted liberty to approach Respondent No. 1, namely the Chancellor of Universities of Bihar, Raj Bhawan, Patna, venting out the grievances made out in the present petition.

We are inclined to accept such prayer and, as such, as prayed for, dispose of the present petition in the following mutually agreeable terms:-

- (a) Petitioner shall approach the appropriate authority, including Respondent No. 1, namely, The Chancellor of Universities of Bihar, Raj Bhawan, Patna, venting out the grievances.
- (b) As and when any such request is received, the same shall be considered and decided in accordance with law, expeditiously and preferably within a period of eight weeks thereafter.
 - (c) The process of appointment and selection in



terms of Advertisement dated 21.09.2020 [Annexure-3] shall continue in terms of the existing statutory provisions, unless, of course, it stands interdicted, in the legislative wisdom of the appropriate authorities.

- (d) We have not expressed any opinion on merits.
- (e) All questions are left open.
- (f) Liberty reserved to the petitioner to approach the Court afresh on the same and subsequent cause of action, if the need so arises. The petition as and when filed shall be taken up on priority basis.

Petition stands disposed of in the aforesaid terms.

Interlocutory Application(s), if any, shall stand disposed of.
