ORAL ORDER

2 30-06-2021 Heard Mr. Ashhar Mustafa, learned counsel for the
petitioner and Mr. Yogendra Kumar Singh, Additional Public
Prosecutor for the State through video conferencing.

2. Petitioner has renewed his prayer for bail inasmuch
as earlier bail application of the petitioner (Annexure-1) was
rejected giving him liberty to renew his prayer after three
months.

3. The allegation, as per FIR, is that the police raided
the house of the petitioner and recovered two country made
pistols along with two live cartridges kept under the pillow on
the bed used by the petitioner and further total quantity of 63
litres of illicit liquors were also recovered from the house of the
petitioner.

4. Learned counsel for the petitioner submits that the
petitioner has falsely been implicated in this case and at the time
of alleged raid, petitioner was not present in his house. Learned
counsel further submits that the said illicit liquor and the



firearms were not recovered from the conscious possession of the petitioner and he is in custody since 12.06.2020.

5. Having regard to the submissions made by the parties and taking into consideration the material on record and the fact that the petitioner is in custody since 12.06.2020, trial is not likely to be concluded in near future due to pandemic situation, I am inclined to grant regular bail to the petitioner subject to the condition that petitioner will be well represented on each and every date in the trial and if he fails to do so on two consecutive dates, his bail bonds will be liable to be cancelled.

6. Accordingly, let the petitioner, MD. SAJID be released on bail on furnishing bail bond of Rs. 20,000/- (Twenty Thousand) with two sureties of the like amount each to the satisfaction of learned Additional Sessions Judge-II-cum-Special Judge (Excise), Sitamarhi in connection with Pupri PS Case No. 35/2020.

7. It is made clear that at the time of furnishing bail bonds all the parties shall follow the covid protocol like social/physical distancing and sporting masks.
