**Per R.More (CJ)**

1. Heard Mr. S.P.Mahanta, learned Sr. counsel for the petitioners and Mr. A.Kumar, learned AG for the respondents.
2. The petitioners in the above applications are situated similarly with the petitioners in MC(WA). No. 35/2020. The petitioners herein have also given explanation for condonation of delay in paragraphs 5, 10, 11, 12, 13, 14 and 15 which we find to be satisfactory.

3. The petitioner members in MC(WA). No. 35/2020 were granted liberty to file representation before the Committee headed by the Chief Secretary/ Additional Chief Secretary, Government of Meghalaya and the said Committee was directed to take a decision on such representations preferably within four months from the date of receipt of the representations. It was further directed if the said Committee accept the representations of the members of the petitioners' association and treat the candidates as untainted, the respondents shall revoke the termination of those teachers and they shall continue in their services as Assistant Teachers in terms of the order dated 14-12-2018 passed by the Division Bench in Review Petition No. 3/2018.

4. In our considered view, since the petitioners in the above applications are similarly situated with that of the petitioners in MC(WA). No. 35/2020, they are entitled for similar treatment. We accordingly disposed of all the above applications by passing the following order:

(i) The petitioners in the above misc. applications are at liberty to file representation before the Committee headed by the Chief Secretary/ Additional Chief Secretary, Government of Meghalaya. Such representations shall be filed within the period of two weeks from today for considering them as untainted teachers. The Committee headed by the Chief Secretary/ Additional Chief Secretary, Government of Meghalaya shall examine the representations of the petitioners in the above misc. applications as per the direction contained in paragraph 2 of the operative part of the order dated 02-11-2017 passed in WA. No. 52/2011 and shall take a decision on such representations expeditiously and preferably within the period of 4(four) months from the date of receipt of the representations. The Committee headed by the Chief Secretary/Additional Chief Secretary, Government of Meghalaya is at liberty to take the assistance of the experts and officers to carry out the scrutiny of the above referred representations expeditiously.

(ii) If the Committee accepts the representations of the petitioners in the above misc. applications and treat them as untainted, the respondents shall revoke the termination of those teachers and they shall continue in their services as Assistant Teachers in terms of the order dated 14-12-2018 passed by the Division Bench in Review Petition No. 3/2018. So far as the petitioners in the above misc. applications whose tainted character is confirmed by the Committee headed by the Chief Secretary/Additional Chief Secretary, Government of Meghalaya are concerned, the consequences as laid down in paragraph 2 of the operative part of the order in WA. No. 52/2011 shall follow.

5. Subject to above, misc. applications are disposed of.
