None appears on call for the petitioners. However, Mr. D. Nath, learned Senior Counsel, assisted by Ms. K. Phukan, learned counsel for the respondent nos. 2 to 5 are present.

It is seen that the stand of the respondents is that the petitioners have been selected, but their position is far below the selected candidate for which they could not be appointed as Sahayaks in the Jorhat Electrical Circle, pursuant to advertisement of the year 2013.

Be that as it may, as it is seen that the petitioners are remained unrepresented when the matter was previously listed on 06.06.2018, 23.01.2019 and 11.01.2021, the Court presumes that the petitioners are not interested to pursue this writ petition.

Accordingly, this writ petition stands dismissed for non-prosecution.
