Heard Mr. PK Roy Choudhury, learned counsel for the petitioner and Mr. R Mazumdar, learned counsel for the respondents in the Secondary Education Department of the Government of Assam. Considering the nature of order proposed to be passed, the other respondents are not required to be heard nor their presence is required before the Court.

2. By this writ petition, the petitioner seeks for a direction to the respondent authorities in the Secondary Education Department that in terms of the guidelines laid down in the Circular dated 18.03.2015, no appointment of any in-

charge Principal be made in violation of the said circular.

3. We have specifically taken note of that the prayer is in respect of in-charge Principal. It is stated that during the pendency of this writ petition, one of the respondents of the writ petition namely Sri Dipak Kalita had been appointed as the regular Principal of the school concerned by following the selection procedure provided under the Rules.

4. As the regular Principal has been appointed, no further adjudication is required in this writ petition for the purpose of in-charge Principal and the writ petition stands closed. However, if the petitioner is aggrieved in any manner in the appointment of the regular Principal, liberty remains to approach the Court again, if so advised.
