Heard Ms. R. Begum, learned counsel for the petitioner whereas Ms. S. Chutia, learned Standing Counsel, Water Resource Department is present for all the respondents.

- 2. Considering the subject matter of dispute and the stand taken by the respondents in their affidavit-in-opposition, the present writ petition is taken up for final disposal at the admission stage.
- 3. The petitioner, who is a registered contractor under the Water Resource Department had executed various works of construction as well as supply in pursuant to the formal work orders issued by the Department. However, even after completion of the works in question, the bills were not cleared. Ms. Begum, the learned counsel for the petitioner submits that the authorities have issued a liability statement wherein the outstanding liability of Rs.4,94,085/has been admitted. Accordingly, the writ petition has been filed for a direction for release of the said payment.
- 4. Ms. S. Chutia, learned Standing Counsel, Water Resource Department by referring to the affidavit-in-opposition filed on 26.08.2021 fairly submits that after making certain part payments, the present liability comes to Rs.4,81,085/- which will be paid as and when funds would be available.
- 5. In view of unequivocal admission of liability, this Court is of the view that the present is a fit case wherein the guidelines laid down in the case of *Tamsher Ali Vs. State of Assam*, reported in *2008 (4) GLT 1* would be applicable.
- 6. Accordingly, this writ petition is disposed of by directing and listing of the petitioner's claim in the chronological list and thereafter release the entitles payment on a *pro rata* basis as and when funds are available.

7.	This writ	petition	accordingly	stands	disposed	of.
