Heard Ms. N. Saikia, learned counsel appearing for the appellants. Also heard Mr. D. Saikia, learned Advocate General, Assam, as well as Mr. S. Khound, learned Standing counsel, Bodoland Territorial Council, appearing for the respondents.

2. The writ appellants before this court have challenged the order dated 15.08.2018, passed by the learned Single Judge after hearing the writ appellants/writ petitioners in a bunch of writ petitions [WP(C) 3865/2016 and other connected writ petitions] as the issue raised by the petitioners in all the writ petitions were common.

3. This matter relates to an area in Assam which is, *inter alia*, under the jurisdiction of the erstwhile Bodoland Autonomous Council (BTC), now known as "Bodoland Territorial Council". The limited jurisdiction to the Autonomous Councils is given in the 6<sup>th</sup> Schedule of the Constitution of India, and it is an admitted position that the Autonomous Councils have certain rights, *inter alia*, over management of primary level schools, including the manner in which the primary education should be imparted in primary schools. The fact, however, remains that for appointment of teachers in the primary schools, the law, which is in force has to be followed

and, more importantly, before appointment is made to a post of teacher in such primary schools, such post must be sanctioned and if a new law pertaining to such appointment is to be enforced then it can be done only with previous approval of the Governor.

4. The material facts which are necessary for our case are that on 31.03.1997, the Deputy Inspector of Schools, Udalguri, issued an "Employment Notice" whereby applications were invited from "intending candidates for the post of "English Teachers" for Bodo medium L.P. Schools, Schools Matri<sup>1</sup> for all provincialized L.P. schools and LDA for the M.E. & M.V. Schools for Udalguri Sub Division". The case of the writ appellants/petitioners is that in response to the aforesaid Employment Notice they applied for the posts of "English Teacher" and were given appointment to teach English in L.P. Schools at a fixed salary of Rs. 900/- per month. The "Employment Notice" clearly states that the selection of the candidates were to be done by the respective Management Committee of the schools. The appointment letters of some of the appellants/writ petitioners, which have been annexed, also shows that the appointments were made purely on temporary basis which could be terminated at any point of time and, more importantly, the appointments were being made on "non-sanctioned posts" of "English Teacher". In order to illustrate, one of the orders of appointment is reproduced below:

"ORDER

*As per approval of the Sub-Divisional Advisory Board for Elementary Education, BAC, Udalguri, final approval of the Director of Education, BAC, Kokrajhar vide his letter No. DE/BAC-EDN/6/97/61 dtd. Kokrajhar, the 3<sup>rd</sup> Nov/97 subject to discharge without notice and without assigning any reason thereof Sri/Smti Ringkhang Khungur Baglari of Vill-Hanglabasti, P.O.-Ambagaon, in the District of Darrang, Assam is hereby appointed to act as English Teacher at Hanglabasti L.P. School against non-sanctioned post under BAC area (Provincialised/Grant-in-aid) of Udalguri Sub-Division at the fixed pay of Rs. 900/- (Rupees Nine Hundred) P.M. only as per new education policy of the BAC w.e.f. the date of selection of the candidate by managing committee of the school.*

*The monthly pay will depend upon the availability of fund allotted by the BAC.*

*He/She will not have any right to claim for undergoing Jr. Basic Training or Deputation till the creation of permanent post and allotted against their name by the BAC or Govt. of Assam.*

5. It must be said at the very threshold that appointments of teachers in primary schools at the relevant time were to be made according to the Rules, known as "Assam Elementary Education (Provincialisation) Rules, 1977 (hereinafter referred

to as "Provincialisation Rules". The procedures relating to appointment of teachers in elementary schools are prescribed under Rule 3<sup>2</sup> of the Provincialisation Rules.

<sup>2</sup> 3. (i) Method of recruitment –In the month of January every year the D. I. shall invite applications in prescribed form for vacancies of elementary schools teachers which are likely to occur in the year in his establishment.

(ii) Age – (a) A candidate shall be within the age limit on 1 st January of the year of recruitment as prescribed by the Government. (b) The upper age limit shall be relaxed, in favour of Scheduled Castes and Scheduled Tribes as per Rules made by the Government.

(iii) Qualification. (a) Matriculation/High School/School Leaving Certificate Examination or any other examination of equivalent standard shall be the minimum qualification for the post of teacher in Lower Primary and Junior Basic Schools preference being given to candidates trained in Senior Basic, Normal and Junior Basic Training Courses.

(b) For M.V. and Senior Basic Schools qualification shall be Matric, Normal or Intermediate or its equivalent.

(iv) Character. A candidate shall furnish the certificates of character from (1) the Principal, Academic Officer of the School/College last attended by the candidate and (b) a respectable person who is well acquainted with (not related to) the candidate

(v) Selection Committee. There shall be a Selection Committee in each educational Sub-Division to be constituted by the Sub-Divisional Level Advisory Board for Elementary Education. The Chairman of the Sub-Divisional Level **Contd.→** Advisory Board for Elementary Education and the D.I. of Schools shall be the Chairman and Secretary of the Selection Committee respectively.

(vi) On receipt of applications, the Selection Committee shall scrutinise the mark sheets and other necessary testimonials of the candidates and prepare a list of candidates for interview by the Selection Committee.

The Selection Committee shall then finalise the list of successful candidates in order of merit after interview and shall put up the list before the Board for approval. While approving the list, the Board shall be guided by the declared policies of the Government and instructions issued by the Government from time to time. After approval of the list by the Board the same shall be sent to the Director of Elementary Education for his final approval.

The Deputy Inspector of Schools will appoint the selected candidates in order of merit from the list approved by the Director of Elementary Education as and when required as per Government Rules and Government instructions for the time being in force.

The list shall be valid for one year unless its validity is extended by Government.

(vii) Reservation. – There shall be reservation of posts for Scheduled Castes and Scheduled Tribes as per rules made by Government from time to time.

(viii) Physical fitness, - (a) A candidate shall be of sound health both physically and mentally and free from organic defects or bodily infirmity likely to interfere with his/her duties.

(b) A candidate shall be required to undergo medical examination and to produce a medical certificate of fitness.

(ix) An appointed candidate may be required to under such in-service training as Government may decide from time to time.



6. The selection of candidate is to be made by the Selection Committee which is constituted under Rule 3(v), which reads as under:

*"(v) Selection Committee. There shall be a Selection Committee in each educational Sub-Division to be constituted by the Sub-Divisional Level Advisory Board for Elementary Education. The Chairman of the Sub-Divisional Level Advisory Board for Elementary Education and the D.I. of Schools shall be the Chairman and Secretary of the Selection Committee respectively.*

*(vi) On receipt of applications, the Selection Committee shall scrutinise the mark sheets and other necessary testimonials of the candidates and prepare a list of candidates for interview by the Selection Committee.*

*The Selection Committee shall then finalise the list of successful candidates in order of merit after interview and shall put up the list before the Board for approval. While approving the list, the Board shall be guided by the declared policies of the Government and instructions issued by the Government from time to time. After approval of the list by the Board the same shall be sent to the Director of Elementary Education for his final approval.*

*The Deputy Inspector of Schools will appoint the selected candidates in order of merit from the list approved by the Director of Elementary Education as and when required as per Government Rules and Government instructions for the time being in force.*

*The list shall be valid for one year unless its validity is extended by Government."*

7. Admittedly, the selection of these English Teachers (writ petitioners/appellants) were not made as per the said Rules, but as we have already noticed, an "Employment Notice" was issued, the writ petitioners/appellants responded to the said "Employment Notice" and they were appointed in the year 1997 as English Teachers purely on temporary basis, against non-sanctioned posts, on a consolidated remuneration of Rs. 900/- per month.

Thereafter, an order was passed on 12.11.2004 by the Bodoland Territorial Council Secretariat, by which the services of these "English Teachers" were terminated. The order reads as under:

**"ORDER**

*In pursuance of Executive Council's Resolution of BTC No. 4 dated 12-10-2004 the Bodoland Territorial Council is pleased to terminate the services of all Mother Teachers, LP English Teachers, LD Asstts. in ME Schools, Malis (Gardeners) in High Schools, Asstt. Teachers in High Schools and Councilised Teachers for which no posts have been sanctioned by Government of Assam.*

*The BTC in pursuant of the Executive Council's Resolution stated above also decides that the BTC is not liable to pay the salaries of these non-existent, non-sanctioned posts.*

*In this connection, the Erstwhile BAC's Executive Council Resolution No. 3 dated 01-11-96 approving the New Education Policy of BAC did not follow the existing Educational Policy of Government of India and Government of Assam.*

*This order will come into force with immediate effect.*

8. The writ petitioners'/appellants' case is that they were not aware of such an order since this order was never served upon them. To the contrary, they submit that they continued to work as English Teachers in Lower Primary Schools but they were not getting their salary.

9. All the same, from the records a different picture appears. It is reflected from the order of the learned Single Judge dated 15.08.2018 that many of the similarly situated persons had earlier filed a writ petition before this court, being WP(C) 4819 of 2011, challenging the order dated 12.11.2004 and seeking their regularisation in service. This writ petition was dismissed by this court vide an order dated 13.02.2012 and the appeal filed by them against the order dated 13.02.2012, being WA 73/2012, was also dismissed by an order dated 23.03.2012.

10. Be that as it may, the writ petitioners/appellants, as per their case, continued to serve as “English Teachers” and, ultimately, some of them filed writ petitions before this court in the year 2017 and some of them filed in the year 2018, wherein their contention was that they had been working as “English Teachers” for more than twenty years and, in terms of the law laid down by the Constitution Bench of the Hon’ble Supreme Court in the case of ***Secretary, State of Karnataka and Others vs. Uma Devi and Others***, reported in ***(2006) 4 SCC 1***, their services were liable to be regularised.

11. The learned Single Judge, while appreciating the facts of the case, picked up one of the writ petitions, i.e. WP(C) 2506/2017, where the petitioners had been appointed pursuant to the said advertisement as Lower Division Assistants (LDA) but not as teachers. In WP(C) 2506/2017 there were total nine writ petitioners out of which eight of them had earlier filed a writ petition, being WP(C) 4918/2011 where they had made prayer for direction to pay regular as well as the arrear salary and also to regularize their services. Their writ petition [WP(C) 4819/2011] was dismissed by the learned Single Judge by an order dated 13.02.2012 wherein it was observed by the learned Single Judge that a counter-affidavit had been filed in the case by the State respondents stating that the services of these writ petitioners had been terminated by an order dated 12.01.2004. These writ petitioners again filed WP(C) 2506/2017. Therefore, they were aware that their services had

been terminated by order dated 12.11.2004, at least they became aware on 13.02.2012 on which date their writ petition [WP(C) 4819/2011] was dismissed. Yet in the subsequent writ petition, i.e. WP(C) 2056/2017 they took a categorical statement that they were not aware of the termination of their services vide order dated 12.11.2004.

12. In the present round of litigation, when the petitioners had filed their claim for regularization of their services, BTC had filed counter-affidavit wherein it has been stated that the services of the petitioners stood terminated way back on 12.11.2004 and, since then they are not getting any salary. After filing of the counter-affidavit by BTC, some of the writ petitioners amended their writ petitions and sought for writ of certiorari quashing the order dated 12.11.2004 as well. The learned Single Judge has given his finding, which is based upon the earlier findings given by other Judges in earlier writ petition that it cannot be accepted that the writ petitioners/appellants were not aware of the order dated 12.11.2004 since it is evident from the fact that the order dated 12.11.2004 was known to some of the petitioners. The learned Single Judge has relied upon the case of ***K. D. Sharma vs. Steel Authority of India Ltd. & Ors***, reported in ***(2008) 12 SCC 481*** and has observed that the present petitioners had, in fact, not come with clean hands and on this aspect alone their writ petitions were liable to be dismissed. The learned Single Judge has categorically observed that, in fact, eight out of the nine writ

petitioners in WP(C) No. 2506/2017 were writ petitioners in WP(C) 4819/2011 and appellants in WA No.73 of 2012, where they had sought payment of salary and regularization of their services, but the writ petition as well as the appeal was dismissed as already noted above. However, these facts were not disclosed by the petitioners in their subsequent writ petitions.

13. In any case, even assuming that the writ petitioners were not aware of the order dated 12.11.2004, the inordinate delay in filing the writ petitions has not been explained by the present petitioners in any manner inasmuch as although they were not getting their salary after 2004, yet they filed writ petitions only in 2017 and 2018 praying for regularization of their services, when admittedly they did not get any salary for a period beyond 12.11.2004. Moreover, the learned Single Judge has rightly held that the ratio of ***Uma Devi's*** case cannot be applied in the case of the petitioners for many reasons but primarily for the reason that admittedly they had been working in non-sanctioned posts.

14. As window of opportunity given by the Constitution Bench judgment in the case of ***Uma Devi*** was for a very limited purpose. The ratio of ***Uma Devi's*** case can be applied only to those cases where irregular but not illegal appointments have been made; where the candidates have been working for the last ten years without the strength of a court's order and, above all, the mandatory conditions are that the candidates

must be qualified and working in sanctioned posts. This, admittedly, is not the case here. Therefore, the services of the writ petitioners are not liable to be regularized as already held by the learned Single Judge. Moreover, the admitted position is that appointment of teacher in primary schools, at the relevant point of time, was to be made under the "Assam Elementary Education (Provincialisation) Rules, 1977, where provisions have been made under Rule 3 that for appointment of teachers in Primary Schools a Selection Committee, constituted by the Sub-Divisional Level Advisory Board, shall hold the interview, finalise the list of selected candidates in order of merit and shall put up the list before the Board for approval. After approval by the Board the same shall be sent to the Director of Elementary Education for final approval and, thereafter, appointments are made by the appointing authority.

15. In the present case, admittedly, these mandatory procedures were not followed while appointing the writ petitioners/appellants. On the contrary, the "Employment Notice" dated 31.03.1997 itself clearly stated that the selection would be made by the "Managing Committee" of the Schools. These appointments were to be made in provincialised schools, where selection is made by a Selection Committee constituted by an Advisory Board, which has Government officials. Therefore, the very selection of the writ petitioners/appellants has been done *de hors* the Rules. Again, as we have already noticed, their appointments were not against sanctioned posts.

Another relevant aspect considered by the learned Single Judge was that there has been inordinate delay in filing the writ petitions by the petitioners and, in fact, the writ petition could have been dismissed on grounds of laches.

16. At this juncture, we may also refer to one judgment of the Hon'ble Supreme Court in the case of ***Nazira Begum Lashkar v. State of Assam***, reported in ***(2001) 1 SCC 143***, which relates to large-scale irregular appointments of primary school teachers in the State of Assam. The facts of the above case are that the Government was facing allegations of having made large scale illegal appointments of government officials without following the prescribed procedure. By order of the High Court (Gauhati High Court) an enquiry was conducted and it was found that the appointments of teachers were in violation of law. A Division Bench of the High Court (Gauhati High Court) came to the conclusion that the appointments were in contravention of the statutory rules and the appointments were cancelled. The order of the High Court was challenged before the Hon'ble Apex Court. It was held by the Hon'ble Apex Court that the appointments were made without selection, interview and the rules applicable for selection and appointment were not followed and, hence, no interference was made with the order of the High Court.

16. We have given thoughtful consideration on the arguments advanced by the learned counsel for the writ petitioners/appellants; learned Advocate General, Assam as



well as the learned Standing counsel, Bodoland Territorial Council. After hearing the learned counsel for the parties at length, we are of the considered opinion that the findings given by the learned Single Judge was based on evidence and the law placed before him and we find that the findings are correct. Therefore, no interference is called for with the order of the learned Single Judge.

17. We find no merit in these appeals and, accordingly, the appeals are dismissed. The interim order dated 13.07.2018 stands vacated.
