**Order No.03 Dated- 30.07.2021**

The matter is taken up through video conferencing.

No one turns up on behalf of the parties.

Perusal of the record reveals that this criminal miscellaneous petition has been filed by the petitioner with a prayer for modification of the order dated 09.06.2021 passed in A.B.A. No.853 of 2021.

Perusal of the record reveals that vide order dated 09.06.2021 passed in A.B.A. No.853 of 2021, the petitioner was directed to surrender before the court below within six weeks and he was further directed to deposit a demand draft of Rs.25,000/- drawn in favour of the opposite party No.2. It is next averred that due to typographical error in the petition of the said anticipatory bail application, the name of surrendering court has wrongly been mentioned as J.M.-1<sup>st</sup> Class, Sahibganj in place of J.M.-1<sup>st</sup> Class, Rajmahal, due to which the petitioner could not surrender within the stipulated time. It is further averred that in the meanwhile the petitioner has already prepared the demand draft of Rs.25,000/- drawn in favour of the opposite party No.2, the copy of which has been annexed with the brief and the petitioner is ready and willing to surrender before the learned court below and unless six weeks' extension is granted to the petitioner and the name of the surrendering court is modified, the petitioner will be highly prejudiced.

Considering the facts of the case, the prayer for extension of time for the petitioner to surrender in the court below in terms of the order dated 09.06.2021 passed in A.B.A. No.853 of 2021 is extended by six weeks from the date of this order and name of surrendering court where the petitioner has to surrender is

also modified. The order dated 09.06.2021 passed in A.B.A. No.853 of 2021 is modified by directing the petitioner to surrender within six weeks from the date of this order in terms of the order dated 09.06.2021 passed in A.B.A. No.853 of 2021 and the said order is further modified to the extent that name of surrendering court is modified as J.M.-1<sup>st</sup> Class, Rajmahal in place of J.M.-1<sup>st</sup> Class, Sahibganj.

The order dated 09.06.2021 passed in A.B.A. No.853 of 2021 is modified to the aforesaid extent only.

This criminal miscellaneous petition is disposed of accordingly.
