- 1. Heard on application (I.A. No.01) for condonation of delay in filing REVP No.71 of 2020.
- 2. The application (I.A. No.01) is considered and allowed.
- 3. Delay is accordingly condoned.
- 4. Out of aforesaid three applications, application of Ram Sajiwan and Ramesh Kumar deals only with certain typographical corrections in paragraph 10 & 14.
- 5. In paragraph 10 of the order, in the 8<sup>th</sup> line, in place of 'respondent', it shall be read in substitution as 'plaintiff'.
- 6. In paragraph 14 of the order, wherever word 'amendment' has been typed, it shall be read in substitution as 'abatement'.
- 7. The basis for seeking review of the order at the behest of the review petitioner- Gulabchand Golchha in REVP No.140 of 2021 is that the finding of the Court that death of Purushottam Das and Sukhi Bai would result in complete abatement proceeded on assumption that legal representatives of Sukhi Bai are not on record whereas Gulabchand Golchha happens to be the legal representative of deceased Sukhi Bai.
- 8. The submission, appears to be more in the nature of appeal in disguise. The effect of death of not only Sukhi Bai but also of Purushottam Das has been taken into consideration by this Court and upon consideration of the facts and legal position applicable, a conclusion has been reached that the appeal will abate as a whole. Therefore, no case is made out for review.
- 9. In the result, REVP No.71 of 2020 and MCC No.500 of 2020 are disposed off with appropriate clarification and REVP No.140 of 2021 is dismissed.
