THE HON'BLE SRI JUSTICE B. KRISHNA MOHAN CRIMINAL PETITION NO.2508 OF 2021

ORDER:

This Criminal Petition is filed by the petitioner/ Accused Nos.1 and 6 against the order passed in Crl.M.P.No.2055 of 2020, dated 21.09.2020 on the file of Additional Junior Civil Judge, Mangalagiri, arising out of the Crime No. 384 of 2020, dated 14.09.2020 of Mangalagiri Rural Police Station, registered for the offences punishable under Sections 420, 188, 269, 270, 271 r/w 34 of IPC and 51(b) DMA-2005, 3 EDA 1897.

- 2. Heard the learned counsel for the petitioners and the learned Assistant Public Prosecutor for the Respondent/ State.
- 3. The learned counsel for the petitioners submits that the Court below passed an order in Crl.M.P.No.2055 of 2020, dated 21.09.2020 directing the petitioners to appear before the Mangalagiri Rural Police Station on every Monday and Friday between 10.00 a.m to 1.00 p.m and sign before the S.H.O, Mangalagiri Rural Police Station till filing of the charge sheet, apart from executing a personal bond of Rs. 10,000/- with two sureties for a like sum each, while granting bail to the petitioners herein and the order of the Court below is being complied with by the petitioners.
- 4. The learned counsel for the petitioners further submits that in view of Covid-19 situation and as there is no requirement of these petitioners further any more, the above said condition may be relaxed. As far as the Accused 4 and 5 are concerned, the above

said condition of appearance was relaxed of the order of the Court

below, by this Hon'ble Court as per the orders in Crl.P.No. 989 of

2021, dated 25.02.2021.

5. On the other hand, the learned Assistant Public Prosecutor

submits that in the above crime investigation is pending, Accused

No. 2 and 3 are yet to be arrested and hence it may be modified

suitably.

7. In view of the above said facts and circumstances, this

Criminal Petition is disposed of, directing the petitioners to appear

before the concerned S.H.O once in a month on a Sunday between

10.00 a.m to 1.00 p.m, till filing of the Charge Sheet, instead of

twice in a week. The petitioners shall cooperate with the police and

the trial court to conclude the proceedings as per law. Accordingly,

the order of the Court below dated 21.09.2020 is modified.
