## THE HON'BLE SRI JUSTICE M.SATYANARAYANA MURTHY WRIT PETITION NO.7345 OF 2019

## **ORDER**:

This writ petition is filed under Article 226 of the Constitution of India seeking the following relief:

"to issue an order or direction more particularly one in the nature of Writ of Mandamus declaring the action of the respondents in not considering the representations dt. 17.08.2015, 28.03.2018 and 23.04.2018 made by the Petitioner's Association for granting or assigning the vacant lands to the members of the Petitioner's Association who are landless poor people as illegal, arbitrary, unjust and contrary to the fundamental rights enshrined under the Constitution and consequently direct the respondents to consider the representations dt. 17.08.2015, 28.03.2018 and 23.04.2018 of the Petitioner's Association for grant or assign the vacant lands to the members of the Petitioner's Association for construction of houses."

Though the petitioner made several allegations against the respondents, during hearing, learned counsel for the petitioner requested this Court, without touching the merits of the case, directing the 2<sup>nd</sup> respondent to dispose of the representations of the petitioner dated 17.08.2015, 28.03.2018 and 23.04.2018.

Learned Assistant Government Pleader for Revenue readily agreed to dispose of the representations of the petitioner dated 17.08.2015, 28.03.2018 and 23.04.2018, if any pending with the authorities.

In view of the submission of the learned Assistant Government Pleader for Revenue, I need not decide the truth or otherwise of the allegations made in the petition. This Court is conscious that no such direction be issued, in view of the judgment of the Apex Court in "*The Government of India v. P.Venkatesh*<sup>1</sup>", wherein the Apex Court held that such orders may make for a quick or easy disposal of cases in overburdened adjudicatory institutions. But, they do no serve to the cause of justice. As the learned counsel for the petitioner himself requested to issue a direction for the 2<sup>nd</sup> respondent to dispose of the representations dated 17.08.2015, 28.03.2018 and 23.04.2018, I find no other alternative except to issue such direction.
