ORDER

Learned AGA accepts notice for respondents.

2. Learned advocate for petitioner and learned HCGP jointly submit that while considering a case with regard to application for transfer of authorization under the Karnataka Essential Commodities (Public Distribution System) Control Order, 2016, ('PDS Order' for short) on compassionate ground, this Court in Smt.Pushpa Vs. The Principal Secretary to Government of Karnataka, Department of Food and Civil Supplies & others (W.P.No.17131/2018 decided on 08.02.2019), has held that two conditions namely, that applicant ought to have passed SSLC and the restriction with regard to the age, as untenable.

3. In view of the above, the following:

<u>ORDER</u>

- i) Writ petition is **allowed**;
- *ii)* The endorsement dated 13.07.2021 issued by respondent No.3 vide Annexure-C is *quashed*;
- iii) Respondent No.3 shall consider petitioner's request made in Annexure-B in terms of order dated 22.04.2021 passed by this Court in W.P.No.17131/2018, within eight weeks from the date of receipt of a copy of this order.
