THIS WRIT PETITION COMING ON FOR ORDERS, THIS DAY, THE COURT MADE THE FOLLOWING:

ORDER

Sri Vigneswara S. Shastri, the learned Senior Counsel for the petitioner, and the learned Additional Government Advocate who accepts notice for respondent Nos.1 to 3, are heard for final disposal.

The petitioner, who does not dispute that the suit commenced by his father in O.S. No.49/1982 has culminated with the final decree in F.D.P. No.11/1995 on the file of the learned Principal Senior Civil Judge, Chitradurga, has sought for directions to the Tahsildar (third respondent) to treat the petitioner as a party in the pending proceeding and to consider his objections with due opportunity to the petitioner.

The learned senior counsel for the petitioner draws attention of this Court to the third respondent -Tahasildhar's order dated 06.12.2021, and it is seen from this order that the third respondent has listed the proceedings on 31.12.2021 recording that the petitioner's counsel has sought leave enter appearance in the proceedings. It is reiterated by the learned Senior Counsel that the request on behalf of the petitioner with the third respondent is to be heard on the objections filed.

In the light of the objections as per Annexure-J, this Court is of the considered view that the petition could be disposed of with liberty to the petitioner to place on record before the third respondent the circumstances relied upon in the present petition and seek order and if such information is placed on record, the third respondent shall consider the same strictly in accordance with law after hearing the petitioner.

The petition stands disposed of accordingly.
