**JUDGMENT**

The petitioners are the accused in C.C.No.2196 of 2017 pending before the Court of the Judicial 1<sup>st</sup> Class Magistrate, Chalakudy. This petition has been filed by the petitioners seeking a direction to the court below to dispose of the case without further delay.

2. When the matter came up before this Court on 19.3.2021, a report has been called from the court concerned regarding the time required for disposal of C.C.No.2196 of 2017. On receipt of this direction, the officer who is holding charge of the Judicial First Class Magistrate, Chalakudy has reported that though PW1 has been examined in chief, further evidence is to be recorded and hence, six months time is required for disposal of the case. As there is no regular sitting for this court and the Judicial First Class Magistrate, Chalakudy is holding full additional charge of this court, I think that the time required for disposal of the case is quite justifiable.

3. Therefore, this report is accepted. The learned Judicial First Class Magistrate, Chalakudy shall dispose of C.C.No.2196 of 2017 within a period of six months from the date of receipt of a copy of this judgment.
