**JUDGMENT**

All that the petitioner seeks for is an expeditious consideration of Ext.P4 application filed by the petitioner in Form No.9 in terms of Rule 12(13) of the Kerala Conservation of Paddy Land and wetland Rules.

2. According to the petitioner, the property in respect of which the application has been filed, is a dry land, but has been erroneously included in the revenue records as "Nilam". The petitioner maintains that the property is not included in the Data Bank maintained under the Act. The property had been lying as garden land much prior to the coming into force of the Land Utilization Order, contends the petitioner. It is for the petitioner to establish the aforesaid facts before the authority by producing the relevant materials including the documents as referred to in Rule 12(13) of the Rules.

without expressing anything on merits, the writ petition is disposed of directing the first respondent to consider Ext.P4 application (Form No.9) and pass orders on obtaining and verifying the relevant materials including the Data Bank, as expeditiously as possible and at any rate within a period of three months from the date of receipt of a copy of this judgment. The petitioner shall be afforded an opportunity of hearing including production of relevant records to substantiate her contentions.
