ADMISSION ON 29.01.2021, THE COURT ON THE SAME DAY
DELIVERED THE FOLLOWING:

JUDGMENT

The petitioners, who are members of the 8th respondent Housing Co-operative Society, have filed this writ petition under Article 226 of the Constitution of India, seeking a writ of mandamus commanding the 6th respondent Secretary, Department of Co-operation to dispose of Ext.P16 appeal filed under Section 83 of the Kerala Co-operative Societies Act, 1969 against Exts.P20 and P21 orders dated 25.02.2020 and 27.02.2020 respectively, issued by the 5th respondent Joint Registrar. The petitioners have also sought for other consequential reliefs.

2. On 17.12.2020, when this writ petition came up for admission, this Court issued notice before admission to the respondents. The learned Government Pleader took notice for respondents 1 to 7 and the learned Standing Counsel took notice for respondents 13 and 14. Notice by speed post was ordered to respondents 8 to 12.

3. On 08.01.2021, when the writ petition came up for consideration, this Court directed the petitioners to place on record the orders dated 25.02.2020 and 27.02.2020 of the Joint Registrar of Co-operative Societies, which are impugned

in Ext.P16 appeal. The learned Government Pleader was directed to get instructions as to the present status of Ext.P16 appeal.

4. Heard the learned counsel for the petitioner, the learned Government Pleader for respondents 1 to 7, the learned counsel for respondents 8, 9, 11 and 12 also the learned Standing Counsel for respondents 13 and 14.

5. Service of notice is not complete on the 10th respondent, who is the erstwhile Secretary of the 8th respondent Society. Considering the nature of relief proposed to be granted, service of notice on the 10th respondent is dispensed with.

6. The learned counsel for the petitioners confine the relief sought for in this writ petition as one directing the 1st respondent State to consider and pass appropriate orders on Ext.P16 appeal, within a time frame to be specified by this Court.

7. The learned counsel for respondents 8 and 9 would submit that the said respondents may be permitted to raise appropriate legal and factual contentions before the 1st respondent at the time of consideration of Ext.P16 appeal.

Having considered the submissions made by the learned counsel on both sides, this writ petition is disposed of directing the 1st respondent State to consider Ext.P16 appeal filed by the petitioners and pass appropriate orders thereon, after adverting to the legal and factual contentions raised by both sides, with notice to the petitioners and other affected parties including respondents 8 and 9 and after affording them an opportunity of hearing, as expeditiously as possible, at any rate, within a period of two months from the date of receipt of a certified copy of this judgment.
