Ernakulam District Auto Drivers Union (INTUC), Valappu Unit represented by its President and five others have jointly filed instant writ petition for a writ of mandamus directing the Superintendent, Survey and Land Records, Ernakulam/respondent No.4, to measure and identify the encroachment made on either side of Valappu Junction-Beach Road on the basis of the sketch plan prior to resurvey and take appropriate action facilitating uninterrupted traffic through the said road.

2. Supporting the prayers sought for, petitioners have contended thus:

The petitioners are the representatives of various autorikshaw employees Union and the residents of Valappu locality of Ernakulam District. They are seeking the intervention of this Hon'ble Court since the long standing demand of the local people to get the encroachment on either side of Valappu Junction-Beach Road verified through the competent authority and get the same evicted, remain unsuccessful in spite of specific orders issued on different occasions by different authorities such as Kerala State Human Rights Commission, the District

Collector, Ernakulam and Deputy Director of Panchayats. A number of buildings were constructed on the encroached land without obtaining any kind of permit, but with the tacit support of local politicians and some of the officers of the 5th respondent Grama Panchayat. The latest among the directions issued by the District Collector, Ernakulam that too on the basis of a specific direction issued by the Kerala State Human Rights Commission is sought to be avoided on the assertion that a special order by the District Collector or judgment by this Hon'ble Court is necessary to verify the encroachment with reference to sketch plan prior to the resurvey. Hence this writ petition is filed.

3. On this day, when the matter came up for hearing, on the basis of the instructions furnished by the Additional Tahsildar, Kochi, Mr. Tekchand, learned Senior Government Pleader submitted that the autorikshaw drivers in Valappu junction are the petitioners and they have filed a petition before the District Collector about the removal of encroachments in Valappu beach road in Elamkunnappuzha Panchayat. They had complained that the encroachments cause severe traffic conjunction in that area. The District Collector directed the petition to the Additional Tahsildar, Kochi to take necessary action. In compliance with the direction from District Collector, an order was issued from the Taluk Office to the Taluk Surveyor for proper survey survey and demarcation of the puramboke road in order to remove the

encroachments. The Taluk Surveyor has identified and reported only five encroachments in that area. The approximate area of encroachments is 31 square metres. On the basis of the Taluk Surveyor's report and sketch, an 'A' form report with sketch mahazar of the identified encroachments were demanded from this office to Village Officer, Elamkunnappuzha.

4. Learned Government Pleader further submitted that petitioners were not satisfied with the survey which was conducted on the basis of the Resurvey records. They filed an appeal before District Collector in the Revenue Adalath. They requested to do the survey of the puramboke road again on the basis of old survey records. The District Collector forwarded the application to the Taluk office to take necessary action. A co-relation sketch/statement of old and Resurvey records of the puramboke road is necessary to do the survey again. Taluk Surveyor has directed to produce the same. At present the survey work is not completed. As per the order of the Additional Tahsildar, the Taluk Surveyor has done the survey of the puramboke road with resurvey records. He has identified and reported the encroachments. The approximate area of the encroachments are 31 square meters and the encroachers are Haider (7m²), Jerry (2m²), Sebastian (13m²), Jenson (6m²), Shibukuttan (3m²), on the basis of Taluk Surveyor's report and sketch, an 'A' form report with sketch mahaesar of above mentioned

encroachments was demanded from the Taluk Office to Village Officer, Elamkunnappuzha.

5. However, Mr. Tekchand, learned Senior Government Pleader is not sure as to whether action for removal of encroachment as per the resurvey and measurement has been taken against the alleged encroachers or not.

6. Be that as it may, by inviting attention of this Court to the Resolution No. 5(1) of ordinary/emergent meeting held on 10.8.2020 passed by Elamkunnappuzha Grama Panchayat, Mr. K.C. Santhosh Kumar, learned counsel for the petitioners submitted that the said Panchayat has resolved to bring to the notice of the Assistant Executive Engineer, PWD to take necessary action for removal of encroachments. Resolution No. 5(1) of ordinary/emergent meeting held on 10.8.2020 passed by Elamkunnappuzha Grama Panchayat is reproduced:

“Elamkunnappuzha Grama Panchayat

The Resolution No.5(1) of ordinary/emergent meeting held
on 10.8.2020

The letter submitted by Valappu Samyuktha Auto Thozhilali Union in respect of encroachment in PWD Valappu Beach Road was discussed. It was found that PWD road which is having high traffic and gathering of general public in large number was found encroached and shops are constructed in the encroached area. It was

resolved to bring this matter to the notice of Assistant Executive Engineer, PWD to take necessary steps to examine the above matter and to evict all such encroachment facilitating smooth traffic in the area.

7. However, no material is produced before this court as to whether the Assistant Executive Engineer has been put on notice of such resolution for removal of alleged encroachment, in accordance with law.

8. During the course of hearing, Mr. K.C. Santhosh Kumar, learned counsel for the petitioner submitted that resurvey has been done about 10 years ago. Though the writ petition has been filed in the year 2015, at this juncture, the prayer sought for to measure and identify the encroachment made on either side of Valappu Junction-Beach Road on the basis of the sketch plan prior to resurvey, cannot be granted for the reason that after ten years, there is every possibility of change of nature of land and extent of the land also. There are also possibilities of competent authorities granting assignment of Government lands on request, if they satisfied the requirement under law. When such be the position, prayer, as on date, cannot be granted.

9. However, as per the statement of the Additional Tahsildar, Kochi, some encroachments have been noticed, as stated supra. There

are no further materials to indicate as to whether action for removal of encroachments has been taken or not.

Having regard to the submission of learned counsel for petitioner and material on record, we direct Tahsildar, Kochi or Elamkunnappuzha Grama Panchayat/5th respondent, as the case may be to take appropriate action in accordance with law, for removal of the alleged encroachment within a period of three months, if not done already.
