JUDGMENT

The above writ petition is filed with the following prayers :

- "i. Issue a writ of Mandamus compelling the respondents 1 to 3 to afford adequate protection to the petitioner and his employees for undertaking, carrying out and completing the work covered by Ext.P1.*
- ii. Issue such other order or direction as this Honourable Court deems fit considering the facts and circumstances of the case.*
- iii. Direct the respondent to pay the cost of the proceedings."*

2. The petitioner had undertaken the work of construction of Men's Hostel of Maharajas College as per Ext.P1. The grievance of the petitioner is that the 4th and 5th respondents are obstructing the construction work. When this writ petition came up for consideration on 26.11.2019, this Court passed an interim order in favour of the petitioner. The

order dated 26.11.2019 is extracted hereunder :

"Admit.

Government Pleader takes notice for respondents 1 to 3. Issue notice by special messenger to respondents 4 and 5. There will be an interim order as prayed for.

H/O"

3. Heard Adv.P.Binny Joseph, who is appearing for the petitioner, Government Pleader and the counsel for the contesting respondents.

4. The counsel for the petitioner submitted that, even now, there is obstruction from the contesting respondents and the work is not completely over. The counsel submitted that the interim order may be retained and the writ petition may be disposed. The contesting respondents vehemently argued that there is an agreement between the petitioner and the employees of the contesting respondents. The petitioner agreed in the agreement that the members of the contesting respondents will also be allowed to work. The counsel for the contesting respondents submitted that there is absolutely no obstruction from the side of the contesting respondents. The counsel submitted that their grievance is that the members of the 4th and 5th respondents are denied work. The Government Pleader

submitted that now, there is no law and order issue and if there is any law and order issue, the Police will do the needful.

5. In the light of the above submissions, I think this writ petition can be disposed, retaining the interim order and allowing the petitioner to approach the Station House Officer concerned, if there is any law and order problem. The contentions of respondent Nos. 4 and 5 are left open. Therefore, this writ petition is disposed, retaining the interim order in the following manner :

1) If there is any law and order issue, the petitioner is free to approach the 3rd respondent.

2) If such a representation is received, the 3rd respondent will do the needful, in the light of the interim order passed by this Court.

3) All other contentions of the respondent Nos. 4 and 5 are left open.
