COMMON ORDER

When the matter was taken up for hearing today, the learned Additional Advocate General submitted that the order passed by this Court has been complied with and a Government order has been passed in G.O.Ms.No.199 dated 08.12.2020, giving notional promotion to the petitioner.

Mr.K.Venkatramani, learned senior counsel appearing on behalf of the petitioner submitted that even though the petitioner has been given notional promotion to the post of Assistant Engineer, Superintending Engineer and Chief Engineer, he has not been paid the attendant benefits. The learned Senior counsel submitted that the petitioner must be given the liberty to challenge the above said Government order.

3. Taking into consideration the facts and circumstances of the case and the subsequent development that has been taken place, these contempt petitions are

closed, by giving liberty to the petitioner to workout his remedy insofar as the claim for attendant benefits are concerned, in the manner known to law.
