In the above circumstances, this petition is allowed by modifying the condition that till filing of the charge sheet, the petitioner is directed to appear before the respondent police on the 1st working day of every English Calender month at 10.30 a.m, and thereafter, the petitioner is directed to appear before the concerned court on each and every hearing dates at 10.30 a.m, until further orders.. Except the above modification condition, all other conditions imposed by this Court in its order dated 25.03.2021 stand unaltered.
