CRIMINAL PETITION No.2594 OF 2021

ORDER:

This Criminal Petition is filed under Section 482 Cr.P.C., to quash the proceedings in C.C.No.868 of 2020 pending on the file of the Judicial Magistrate of First Class, Thungaturthy, Nalgonda District. The petitioners herein are accused Nos.2 and 3 in the said C.C.

2. Heard Sri M. Achutha Reddy, learned counsel for the petitioners and learned Public Prosecutor. Perused the Record.

4. The offences alleged against the petitioners herein are under Sections 498-A and 509 of IPC and Sections 3 and 4 of Dowry Prohibition Act. A perusal of the charge sheet would reveal that there are general allegations against the petitioners herein/ A-2 and A-3. It appears that the allegations are against A-1 only. Petitioners herein are aged parents of A-1.

3. Though the petitioners raised several grounds and contentions seeking to quash the proceedings in C.C.No.868 of 2020, they have restricted their relief only to the extent of dispensing with their presence in the said C.C.

5. Considering the said facts, the presence of petitioners herein/ A-2 and A-3 in C.C.No.868 of 2020 pending on the

file of the Judicial Magistrate of First Class, Thungaturthy, Nalgonda District, is dispensed with. However, it is made clear that they shall appear before the said Court as and when their presence is required.

6. The Criminal Petition is accordingly disposed of. Miscellaneous petitions pending, if any, shall stand closed.
