ORDER:

Heard learned counsel for the petitioner and learned Government Pleader for Revenue appearing for the respondents.

2. Petitioner claims that she has acquired the land admeasuring Ac.3-00 guntas in survey No.346/u and Ac.2-28 guntas in survey No.333/A/1 and Ac.2-22 guntas in survey No.334/U situated at Urkonda Revenue Village, Nagarkurnool Mandal, Mahaboobnagar District through registered sale deed having purchased the same from vendor by name Mamtha. She further submits that she submitted F-line application on 08.10.2020 requesting to conduct survey and fix the boundaries. Alleging inaction, this writ petition is filed. A copy of the receipt issued by TSTS Limited acknowledging submission of application in F-line mode is filed at Page No.22 of the writ petition paper book.

3. In view thereof, without entering into merits, the Writ Petition is disposed of directing the Tahsildar-3rd respondent to consider the application submitted by petitioner for conducting survey and to fix the boundaries. If the said application is otherwise in order, the 3rd respondent may direct the Mandal Surveyor to conduct survey by strictly following the circular instructions issued from time to time by the Commissioner for Survey Settlements and Land Records, if necessary by putting on notice the adjacent property owners within eight (8) weeks from the date of receipt of copy of this order. For any reason the Tahsildar is

not in agreement to conduct survey he shall pass orders assigning reasons in support of the decision and communicate the same to the petitioner within a period of four (4) weeks from the date of receipt of copy of this order. Pending miscellaneous petitions, if any, shall stand closed.
