Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue any appropriate writ, order or direction particularly one in the nature of WRIT OF MANDAMUS, declaring the action of the Respondent No.2 in not initiating any action upon the representation of the Petitioner dated 02-03-2021 through Whatsapp Mobile No.9492837644 at about 11.59 AM from the Petitioner Mobile No.9866023898, in cancellation of the Third party Gift Deeds executed by Late Jangili Mallaiah who was the father of Jangili Kishan Rao and Jangili Srinivas Rao, vide Doc.No.5254/1992, Doc. No.5255/1992 dated 02-11-1992 registered at SRO, Suryapet, to grab the land standing in the name of Petitioner's father in connected with revenue records in the year 1992 and depriving the right to property of the father of the Petitioner is illegal, arbitrary, violation of the Articles 14, 19, 21 and 300-A of Constitution of India and consequently direct the Respondent No.1 to give the clear instructions to the Respondent No.2 to forthwith cancel the fraudulent Gift Deeds executed by Late Jangili Mallaiah who was the father of Jangili Kishan Rao and Jangili Srinivas Rao, vide Doc.No.5254/1992, Doc.No.5255/1992 dated 02-11-1992.
