Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue Writ, order or direction particularly one in the nature of WRIT OF MANDAMUS declaring the action of respondents in not considering the application dated 04/03/2021 for compassionate appointment due to the death of the petitioners father, as illegal arbitrary and violative of principles of natural justice and consequently direct the respondents to consider representations dated 03/10/2020, 12/02/2021 and application dated 04/03/21 for appointing the petitioner on any suitable post on compassionate grounds due to the death of petitioner father.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents to consider representations dated 03/10/2020, 12/02/2021 and application dated 04/03/21 for appointing the petitioner on any suitable post on compassionate grounds due to the death of petitioner father, pending disposal of the main Writ petition.

WRIT PETITION No.12021 of 2021

ORDER:

This writ petition is being disposed of at the admission stage with the consent of both parties.

This writ petition is filed seeking the following relief:

".....to issue a Writ of Mandamus declaring the action of the respondents in not considering the application dt.04.03.2021 for compassionate appointment due to the death of the petitioner's father as illegal, arbitrary and violative of principles of natural justice and consequently direct the Respondents to consider representations dated 03.10.2020, 12.02.2021 and application dated 04.03.2021 for appointing the petitioner on any suitable post on compassionate grounds due to the death of petitioner's father .....".

Record learned counsel appearing for the petitioner and the learned Government Pleader for Services-I,

It has been contended by the petitioner that her father while working as Head Master in the 3<sup>rd</sup> respondent School expired on 03.07.2020. She has submitted detailed representations to the respondents on 03.10.2020, 12.02.2021 and 04.03.2021 seeking compassionate appointment. But, so far, the respondents have not passed any orders on the said representations.

Therefore, learned counsel appearing for the petitioner had contended that appropriate orders be passed in the writ petition directing the respondents to consider the representations submitted by the petitioner and pass appropriate orders in accordance with law.

Learned Government Pleader appearing for the respondents had contended that since the representations are pending with the respondents, the respondents would consider the same and pass appropriate orders in accordance with law,

This Court, having considered the rival submissions of learned counsel for the parties, is of the considered view that this writ petition can be disposed of directing the respondents to consider the representations submitted by the petitioner on 03.10.2020, 12.02.2021 and 04.03.2021 and pass appropriate orders in accordance with law, within a reasonable period of time, preferably within eight weeks from the date of receipt of a copy of this order.

With the above directions, the writ petition is disposed of. No order as to costs.

Fending miscellaneous petitions, if any, shall stand closed.
