**CRIMINAL PETITION No.3988 OF 2021**

**ORDER:**

This is an application for regular bail. The petitioner herein is the sole accused in Crime No.233 of 2021, pending on the file of Police Station, Pet Basheerabad, Cyberabad Commissionerate. The offences alleged against the petitioner herein are under Sections 304-II of IPC and Sections 181 and 196 of the Motor Vehicles Act, 1988.

2. Heard Sri K. Venumadhav, learned counsel for the petitioner and learned Assistant Public Prosecutor.

3. The petitioner herein is an auto driver. The allegation against him is that he drove the Auto in a rash and negligent manner causing death of a person.

4. As per the remand report, the Investigating Officer has examined 15 witnesses. Therefore, the investigation is almost completed and charge sheet is yet to be filed. The Police have arrested the petitioner on 15.03.2021 which shows that the petitioner is in jail since 74 days.

5. Considering the above said aspects, this Court is inclined to grant regular bail to the petitioner herein.

6. Accordingly, the Criminal Petition is allowed and the petitioner shall be released on regular bail subject to the following conditions:

(i) The petitioner shall execute personal bond for a sum of Rs.10,000/- (Rupees ten thousand only) with two sureties for the like sum each to the satisfaction of the XXII Additional Metropolitan Magistrate, Cyberabad at Medchal.

(ii) The petitioner shall appear before the Station House Officer, P.S., Pet Basheerabad, Cyberabad Commissionerate, on every Sunday between 10.00 AM and 5.00 PM, till completion of investigation and filing of final report.

(iii) The petitioner shall cooperate with the Investigating Officer.

Miscellaneous petitions pending, if any, shall stand disposed of.
